21/061	 Clerks report – Info only. Correspondence received and outstanding action points: DriveSafe – The lead volunteers have completed their induction and are now in a position to begin roadside monitoring. Hertfordshire constabulary are currently trying to arrange for equipment to be stored more locally but in the meantime they are finding out if the lead volunteers would be happy to temporarily use the equipment from Hitchin Police Station. Once this is confirmed they can move forward with the date for their first session. Land behind Graveley House – The Clerk wrote a letter to the development company and received an email back to say that they were will be more than happy to assist if they could, but on visiting the land they do not feel that there are any tree trunks that will be suitable. Results of the water sampling:- Sustrans (Cycle path) The larger pond (labelled south) for the two sites returned a positive result for Great Crested Newts, indicating that they use this pond. The smaller pond (labelled north) in the returned a negative result. Croudace (promoting land north of Stevenage, but in the Graveley Parish) Both ponds returned a negative result, indicating that there would not appear to be any Great Crested Newts living in these ponds at present.
